**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of August 10, 2004 ("Effective Date") by and between COMMERCIAL VEHICLE SYSTEMS, INC., a Delaware corporation, with its principal office at 171 Great Oak Drive, Canton, North Carolina 28716 ("Grantor"), and BANK OF AMERICA, N.A., a National Association, with its principal office at 231 S. LaSalle Street, Chicago, Illinois 60603, as Collateral Agent ("Collateral Agent").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Collateral Agent dated March 31, 2000 (the "Trademark Security Agreement"), Grantor granted to Collateral Agent a continuing security interest in and to all of Grantor's right, title and interest in and to the Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, the United States applications for trademark registration set forth on Schedule B attached hereto, and the foreign trademark registrations set forth on Schedule C attached hereto, in each case, together with the goodwill associated therewith (collectively, the "Trademarks");

**WHEREAS**, Grantor and Collateral Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and between Grantor, CVS Holdings, Inc. and Collateral Agent dated March 31, 2000 (the "Credit Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on May 10, 2001 at Reel 002430, Frame 0089;

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Collateral Agent; and

**WHEREAS**, the Collateral Agent wishes to: (i) terminate the Trademark Security Agreement and the Credit Agreement; (ii) terminate, cancel and release any and all security interests it has against the Trademarks; (iii) restore all right, title and interest in and to the Trademarks to Grantor; and (iv) dissolve any and all liens and encumbrances with respect to the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent does hereby release its security interest in the Trademarks, including those set forth on Schedules A, B and C attached hereto, and discharges, quit claims and relinquishes unto Grantor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and the security interest granted to Collateral Agent in the Trademarks, including those listed in the aforementioned schedules.


