TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release") is given as of this ~~3rd~~ day of August, 2004 by Bank of America, N.A. (formerly Bank of America National Trust and Savings Association, "Assignor"), to Evenflo Company, Inc., Lisco Furniture, Inc., and Lisco Feeding, Inc. (collectively, the "Assignees") as follows:

WHEREAS, Assignor and Assignees entered into a Security Agreement, dated as of March 30, 1998 (the "First Security Agreement") which was recorded in the United States Patent and Trademark Office on May 21, 1998 at Reel 1737 Frame 0738, pursuant to which Assignees granted to Assignor a first priority security interest in the Trademark Collateral (as defined in the First Security Agreement, the "First Trademark Collateral"), including without limitation the registrations and applications identified in Exhibit A to this Release (the "Released Trademarks"), as collateral security for the prompt and complete payment and performance when due, whether at the stated maturity, by acceleration, upon one or more dates set for prepayment or otherwise of the Obligations (as defined in the First Security Agreement, the "First Obligations");

WHEREAS, the Assignees have fully satisfied all of their First Obligations under the First Security Agreement and Assignor wishes to release its first priority security interests in any of the First Trademark Collateral owned by Assignees;

WHEREAS, Assignor and Assignees entered into a Security Agreement, dated as of March 31, 1998 (the "Second Security Agreement") which was recorded in the United States Patent and Trademark Office on May 22, 1998 at Reel 1739 Frame 0001, pursuant to which Assignees granted to Assignor a first priority security interest in the Trademark Collateral (as defined in the Second Security Agreement, the "Second Trademark Collateral") including without limitation the Released Trademarks, as collateral security for the prompt and complete payment and performance when due, whether at the stated maturity, by acceleration, upon one or more dates set for prepayment or otherwise of the Obligations (as defined in the Second Security Agreement, the "Second Obligations");

WHEREAS, Assignees have fully satisfied all of their Second Obligations under the Second Security Agreement and Assignor wishes to release its first priority security interests in any of the Second Trademark Collateral owned by the Assignees;

WHEREAS, Assignor and Assignees entered into a Security Agreement, dated as of August 20, 1998 (the "Third Security Agreement") which was recorded in the United States Patent and Trademark Office on September 8, 1998 at Reel 1787 Frame 0158, pursuant to which Assignees granted to Assignor a first priority security interest in the Trademark Collateral (as defined in the Third Security Agreement, the "Third Trademark Collateral") including without limitation the Released Trademarks, as collateral security for the prompt and complete payment and performance when due, whether at the stated maturity, by acceleration, upon one or more dates set for prepayment or otherwise of the Obligations (as defined in the Third Security Agreement, the "Third Obligations");

WHEREAS, Assignor has previously released its first priority security interest in the Third Trademark Collateral and desires to reaffirm such release;

WHEREAS, Assignor and Assignees entered into an Amended and Restated Security Agreement, dated as of December 18, 2002 (the "Fourth Security Agreement") which was recorded in the United States Patent and Trademark Office on December 23, 2002 at Reel 2588 Frame 0466, pursuant to which Assignees granted to Assignor a first priority security interest in the Trademark Collateral (as defined in the Fourth Security Agreement, the "Fourth Trademark Collateral") including without limitation the Released Trademarks, as collateral security for the prompt and complete payment and performance when due, whether at the stated maturity, by acceleration, upon one or more dates set for prepayment or otherwise of the Obligations (as defined in the Fourth Security Agreement, the "Fourth Obligations"); and

WHEREAS, pursuant and subject to that certain Payoff Letter, dated as of August 3, 2004, Assignor has agreed to release its first priority security interests in the Fourth Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby releases its security interest in any of the First Trademark Collateral owned by the Assignees, including without limitation the Released Trademarks, and reassigns any and all interest it may have in such of the First Trademark Collateral to the Assignees.

2. Assignor hereby releases its security interest in any of the Second Trademark Collateral owned by the Assignees, including without limitation the Released

Trademarks, and reassigns any and all interest it may have in such of the Second Trademark Collateral to the Assignees.

3. Assignor hereby reaffirms the release of its security interest in the Third Trademark Collateral and the reassignment of any and all interest it may have in such Third Trademark Collateral to the Assignees.

4. Assignor hereby releases its security interest in the Fourth Trademark Collateral and reassigns any and all interest it may have in such Fourth Trademark Collateral to Assignees.

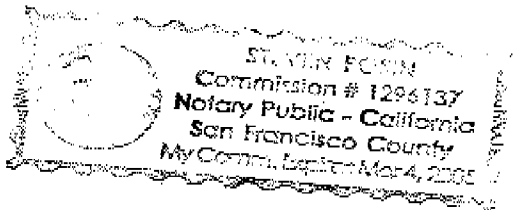
