RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated July 26, 2004 by Harris Trust and Savings Bank as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, as Agent (the "Assignee"), and HK Systems, Inc., a Wisconsin corporation with its mailing address at 2855 South James Drive, New Berlin, Wisconsin 53151, (the "Assignor") are parties to the following certain Trademark Collateral Agreements:

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



(ii) The goodwill of the business to which each of the Trademarks relates.
