**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated July 21, 2004 by Harris Trust and Savings Bank as hereinafter described;

**WITNESSETH:**

(i) Each Trademark, Trademark Registration and each Trademark Application listed on Schedule B attached hereto and made a part hereof, including without limitation all renewals thereof, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, and all rights corresponding thereto throughout the world;

(ii) The goodwill of the business to which each of the Trademarks relates.
