**ASSIGNMENT FOR SECURITY****TRADEMARKS**

**WHEREAS, CMS GILBRETH PACKAGING SYSTEMS, INC.** (the "Assignor") has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

**WHEREAS,** the Assignor has entered into a Security Agreement, dated July 12, 2004 (the "Security Agreement"), in favor of **ABLECO FINANCE LLC**, as collateral agent for certain lenders (in such capacity, together with any successors and assigns, the "Assignee");

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
