**RELEASE**

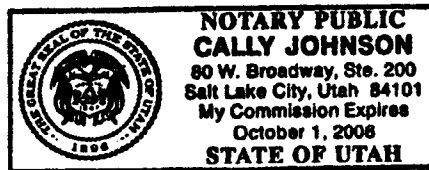
