

**THIS ASSIGNMENT** is made on 5 November, 2003.

**BETWEEN:**

- (1) **CHYRON CORPORATION** a company incorporated under the laws of New York whose registered office is at 5 Hub Drive, Melville, New York, 11747, New York, USA ("the Assignor"); and
- (2) **PRO-BEL LIMITED** a company incorporated under the laws of England whose registered office is Hartman House, Danehill, Lower Earley, Reading, Berkshire, England RG6 4PB ("the Assignee").

**IT IS AGREED AS FOLLOWS:**

**1 ASSIGNMENT**

In consideration of the payment of the sum of £1.00 now paid by the Assignee to the Assignor (receipt of which the Assignor acknowledges), the Assignor assigns to the Assignee with full title guarantee all legal and beneficial interest, free from all charges, liens or other encumbrances however arising in:

- 1.1 the registered trade marks listed in the Schedule (the "Trade Marks");
- 1.2 any and all goodwill that may subsist in relation to the Trade Marks;
- 1.3 all rights of action that may have accrued in respect of any and all of the rights described above.

**2 FURTHER ASSURANCE**

The Assignor shall at the Assignee's request and cost execute all such documents and do all such acts and things as may be necessary or desirable for perfecting the assignments in Clause 1, for vesting any relevant trade mark or other right in the Assignee absolutely and for enabling the Assignee to become registered as the proprietor of the Trade Marks on the relevant public register.

**3 WAIVER**

Any failure or delay on the part of either party to exercise any right or power under this Assignment shall not operate as a waiver of it nor shall any single or partial exercise of any such right or power preclude any further exercise of the right or power. Any of the rights and remedies of either party under this Assignment may at any time be enforced separately or concurrently with any other rights and remedies, whether under this Assignment or arising by operation of law with the effect that the rights and remedies are cumulative and not exclusive of each other. The waiver by either party of any breach of the terms of this Assignment shall not be deemed to be a waiver of any other breach of this Assignment.

**4 NOTICES**

- 4.1 **Writing**

All notices and communications between the parties with respect to this Assignment shall be in writing and signed by the party giving it.

#### 4.2 Service

Any notice or communication referred in this Clause shall be served by delivering it:

- 4.2.1 by hand;
- 4.2.2 by sending it by first-class post, recorded delivery or air mail; or
- 4.2.3 by fax,

to the address of the addressee set out below, or to such other address as the addressee may from time to time have notified for the purpose of this Clause.

#### 4.3 Deemed delivery

Notices shall be deemed to have been received:

- 4.3.1 if sent by first-class post, two (2) business days after posting exclusive of the day of posting;
- 4.3.2 if delivered by hand or sent by recorded delivery, on the day of delivery;
- 4.3.3 if delivered by air mail, five (5) business days after posting exclusive of the day of posting;
- 4.3.4 if sent by fax, at the time of transmission unless received after normal office hours in the place of receipt in which case it shall be deemed to have been received on the next business day in the place of receipt.

#### 4.4 Proof of service

In proving service:

- 4.4.1 of delivery by hand or recorded delivery, it shall be necessary only to produce a receipt for the communication signed by or on behalf of the addressee;
- 4.4.2 by post, it shall be necessary only to prove that the communication was contained in an envelope which was duly addressed and posted in accordance with this Clause; and
- 4.4.3 by fax, it shall be necessary only to produce the sender's transmission slip bearing the addressee's fax number.
