**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of September 28, 2004, is made by BANK OF AMERICA, N.A., as Collateral Agent ("B of A"), pursuant to the termination of the Grant of Security Interest ("Security Interest") dated October 20, 1999.

WITNESSETH

WHEREAS, pursuant to the Security Interest dated October 20, 1999, and recorded with The United States Patent and Trademark Office on November 15, 1999 at Reel/Frame No. 1984/0485, Knoll, Inc. ("Knoll") granted B of A a security interest in its trademarks and all applications and registrations therefore, including goodwill;
