RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "**Release**"), dated as of July 30, 2004, is made by U.S. Bank National Association, as administrative agent (the "**Administrative Agent**") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, Merrill Communications LLC (the "**Borrower**") and the Administrative Agent entered into that certain Credit Agreement, dated as of November 23, 1999 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "**Credit Agreement**"), among the Borrower, Merrill Corporation, as Holdings, the Administrative Agent and the various financial institutions party thereto as lenders thereunder (each individually a "**Lender**", and collectively the "**Lenders**"), pursuant to which Credit Agreement the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to certain intellectual property security agreements (collectively, the "**Security Agreements**"), Holdings, the Borrower and certain of the Borrower's Subsidiaries (collectively, the "**Grantors**" and each a "**Grantor**") granted security interests in certain intellectual property owned by such Person listed on Annex I attached hereto (collectively, the "**Patent and Trademark Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto;

NOW THEREFORE, the Administrative Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Patent and Trademark Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Patent and Trademark Collateral to the Grantor that shall have granted such security interest to the Administrative Agent (or its successor).

The Administrative Agent agrees, at the Borrower's expense, to cooperate with the Borrower and its Subsidiaries and to provide the Borrower and its Subsidiaries with any information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.
