
TERMINATION OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS
AND SERVICE MARKS

Reference is made to that certain Security Agreement, dated September 17, 1999 (as amended from time to time, the "Security Agreement"), among RUTH'S CHRIS STEAKHOUSE, INC., a Louisiana corporation ("Borrower") having an office at 3321 Hessmer Avenue, Metairie, Louisiana 70002, as successor in interest to Ruth U. Fertel, Inc., a Louisiana corporation, and certain of its subsidiaries (together with Borrower, each an "Assignor" and, collectively, the "Assignors"), and DEUTSCHE BANK TRUST COMPANY AMERICAS (f/k/a Bankers Trust Company), as collateral agent (the "Collateral Agent"), having an office at 60 Wall Street, New York, New York 10005-2858, pursuant to which the Assignors granted to the Collateral Agent a security interest in all right, title and interest in and to (i) the United States trademarks, service marks, trademark and service mark registrations and trademark and service mark applications set forth on Schedule A attached hereto and made a part hereof (the "Marks"), (ii) all Proceeds (as such term is defined in the Security Agreement), (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising for infringement of any of the Marks or unfair competition regarding the Marks (the "Trademark Collateral").

Pursuant to Section 10.8 of the Security Agreement, the Collateral Agent hereby acknowledges the satisfaction and termination of the Security Agreement and the termination of the Collateral Agent's security interest in the Trademark Collateral.
