**TRADEMARK ASSIGNMENT**

WHEREAS, Assignor was administratively dissolved by the Secretary of State of the State of Iowa on August 5, 2002;



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and sets over to the Parent the entire right, title and interest for the territory of the United States of America and all foreign countries in and to the Trademark Rights, together with the goodwill of the business symbolized by the Trademark Rights, together with all claims for damage by reason of past infringement of said trademarks, including the right to sue for and collect the same for its own use and on behalf of and for its successors and assigns.
