2. Assignor hereby authorizes and requests the Commissioner of the United States Patent and Trademark Office, and all other foreign bureaus or offices whose duty it is to issue patents or register trademark and service mark registrations, to record this Assignment, and to issue or register as appropriate, the same to Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives in accordance with the terms of this Assignment.

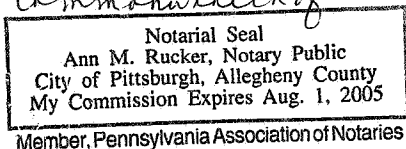
