Assignor binds itself and its successors to warrant and forever assist Jackson/Charvel Manufacturing, Inc., d/b/a T & G Company, to defend all and singular the intellectual property referenced herein to Jackson/Charvel Manufacturing, Inc., d/b/a T & G Company, its successors and assigns, as directed by Jackson/Charvel Manufacturing, Inc., d/b/a T & G Company.

AND, Assignor hereby warrants and covenants that it has the full right to convey the entire interest herein assigned and that it will not execute any agreements inconsistent herewith.

AND, Assignor agrees to execute any instruments to perform any acts that may be necessary to fully effectuate and record this Assignment.
