# Trade Mark Assignment

The Gates Corporation

and

Interfloor Limited

THIS ASSIGNMENT is made on 28 March 2003

**BETWEEN:**

- (1) **The Gates Corporation**, a company incorporated in Delaware, USA whose registered office is at 900 South Broadway, Denver, Colorado, 80209, USA; (the "Assignor"); and
- (2) **Interfloor Limited** (no. 4407328), a company incorporated in England and Wales whose registered office is at Broadway, Haslingden, Rossendale, Lancashire BB4 4LS; (the "Assignee").

**RECITALS**

Pursuant to the acceptance of an offer made by Gates (UK) Limited ("Gates") to Interfloor Limited on 15 May 2002 by way of offer letter and accompanying appendix (the "Agreement"), Gates agreed to procure the Assignor to assign the registered trade marks and application for registration of trade mark set out in the attached schedule (the "Trade Marks") to the Assignee and the Assignor has agreed to make such assignment on the terms set out in this assignment.

**THE PARTIES AGREE AS FOLLOWS:**

1. In pursuance of the Agreement the Assignor does **HEREBY ASSIGN** and transfer such right, title and interest to and in the Trade Marks as it may have, including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action, to the Assignee.
2. The Assignor confirms that this assignment is made with the goodwill attaching to the Trade Marks and the goodwill of the business in which the Trade Marks have been used by the Assignor.
3. The Assignor shall at the expense of Gates do and execute or procure that there shall be done and executed all such documents, deeds, matters, acts and things as the Assignee may at any time require properly to vest such right, title or interest in the Trade Marks or any one or more of them as they may have in the Assignee or otherwise to give effect to this assignment and perfect the Assignee's title (save for recording this assignment or related country assignments at national Trade Mark Registries on behalf of the Assignee which shall be the responsibility of the Assignee).
4. This assignment (and any dispute, claim, proceeding or controversy in relation to it or its formation) shall be governed by and construed in accordance with English law and the English courts shall have exclusive jurisdiction in respect of it.
