**RELEASE OF SECURITY INTEREST**

This Release of Security Interest, effective as of 11-10-04, (the "Effective Date"), is made by THE CIT GROUP/COMMERCIAL SERVICES, INC. ("Grantee"), in favor of FRANCINE BROWNER, INC. ("BROWNER").

WHEREAS, on April 30, 1997, BROWNER and Grantee entered into that certain Grant of Security Interest in Patents, Trademarks and Licenses (the "Security Agreement") which provided for the grant by Browner to Grantee of a security interest in Trademark Collateral (as that term is defined in the Security Agreement) owned by Browner; and

WHEREAS, on June 30, 1997, Grantee recorded in the Patent and Trademark Office, U.S. Department of Commerce at Reel/Frame 1604/0131, the Security Agreement, evidence of its security in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, as of the Effective Date, Grantee hereby (1) releases, discharges and relinquishes its security interest in all of the Trademark Collateral, as listed on Schedule A, and (2) reassigns to Browner all right, title, and interest that Grantee may have had in the Trademark Collateral, including all goodwill associated with the Trademark Collateral. Grantee specifically acknowledges that the Security Agreement is no longer effective as to the Trademark Collateral, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Trademark Collateral.

Grantee acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Trademark Collateral.
