RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS

WHEREAS, GMAC COMMERCIAL FINANCE LLC, successor by merger to GMAC COMMERCIAL CREDIT LLC (hereinafter collectively referred to as "GMAC CF") is a limited liability company of the State of Delaware and has an address of 3000 Town Center, Suite 280, Southfield, Michigan 48075;

AND, the Hoover Companies, by these presents, do hereby confirm that each has assigned, to Mauser, its entire right, title, and interest in and to the MARKS and the goodwill associated therewith, along with the right to recover for damages and profits and other remedies for past infringements of the MARKS and, to the extent necessary to convey title to Mauser, each does again hereby assign, to Mauser, its entire right, title, and interest in and to the MARKS and

the goodwill associated therewith, along with the right to recover for damages and profits and other remedies for past infringements of the MARKS.
