RELEASE OF TRADEMARK SECURITY AGREEMENT

1.

Any right, title or interest of the Grantee in such Trademark Collateral shall hereby cease and become void.

The Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at Grantor's expense.
