RELEASE OF LIEN IN CERTAIN TRADEMARKS

This RELEASE OF LIEN IN CERTAIN TRADEMARKS is given as of this 1st day of June 2004 by JPMORGAN CHASE BANK, a New York banking corporation, as Collateral Agent (as defined in the Guarantee and Collateral Agreement) for the Secured Parties (as defined in the Guarantee and Collateral Agreement) ("Assignor"), in favor of WKI HOLDING COMPANY, INC., a Delaware corporation ("WKI"), and the Subsidiary Parties (as defined in the Guarantee and Collateral Agreement), including World Kitchen, Inc., EKCO Group, LLC, World Kitchen (GHC), LLC, EKCO Housewares, Inc., EKCO Manufacturing of Ohio, Inc., and WKI Latin America Holding, LLC (WKI and the Subsidiary Parties, collectively, the "Assignee").

WHEREAS, pursuant to a Guarantee and Collateral Agreement dated as of January 31, 2003 (the "Guarantee and Collateral Agreement"), by and between Assignee and Assignor, Assignee assigned, pledged, and granted a security interest in all of Assignee's right, title and interest in and to Assignee's Trademarks, together with all goodwill associated therewith or symbolized thereby, all other assets, rights and interests that uniquely reflect or embody such goodwill, and including the U.S. trademark and trademark applications set forth on Schedule A hereto (the "Trademarks"), and all Proceeds, Supporting Obligations and products of the Trademarks (collectively with the Trademarks, the "Collateral"), to secure the payment or performance, as the case may be, of all of the Obligations (as defined in the Guarantee and Collateral Agreement).

WHEREAS, the Guarantee and Collateral Agreement was recorded in the United States Patent and Trademark Office, including on March 21, 2003, at Reel 2692/0342;

WHEREAS, Assignor is the successor by merger to the Chase Manhattan Bank, which, pursuant to a Security Agreement dated April 12, 2001 (the "Security Agreement") held a security interest in the Collateral as Administrative Agent (as defined in the Security Agreement) for the lenders under such Security Agreement, which Security Agreement was recorded in the United States Patent and Trademark Office, including on April 23, 2001 at Reel 2273/0351;

WHEREAS, pursuant to the Acquisition Agreement dated as of April 29, 2004, (the "Acquisition Agreement") by and among World Kitchen (GHC), LLC, WKI, World Kitchen, Inc., (collectively, "Sellers"), and Helen of Troy Limited (Barbados) and Helen of Troy Limited (Bermuda) (collectively, "Purchasers"), Sellers agreed to assign to Purchasers all of their respective right, title, and interest in certain assets comprising the business of the Assignee referred to as "OXO" (the

"Transferred Assets"), including the Collateral, free and clear of all Encumbrances (as defined in the Acquisition Agreement); and

WHEREAS, Assignor has consented to such assignment and has agreed to release its security interest in the Transferred Assets, including the Collateral, while retaining its security interest in the remaining Trademarks listed in the Guarantee and Collateral Agreement which were not assigned to Purchasers pursuant to the Acquisition Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interests in the Collateral to Assignee and, without representation, warranty or recourse of any kind, reverts the Assignee with full title to the Collateral.
