ASSIGNMENT OF TRADEMARKS

WHEREAS, Kimberly-Clark and Assignee are parties to a Distribution Agreement dated as of November 30, 2004 ("Distribution Agreement"), pursuant to which Kimberly-Clark agreed to transfer and assign, or cause to be transferred and assigned, to Assignee the business, operations, assets and liabilities related to the Neenah Business (as defined in the Distribution Agreement) and Assignee has agreed to the transfer and assignment of such assets and to assume, or cause to be assumed, substantially all of the liabilities and obligations arising out of or relating to the Neenah Business;

WHEREAS, in connection with the Distribution Agreement, Assignor desires to assign its right, title, and interest in the marks listed on Schedule A ("Marks");


WHEREAS, pursuant to the terms of the Distribution Agreement, Assignee desires to acquire all right, title, and interest in and to the Marks;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, conveys and transfers to Assignee all of Assignor's right, title, and interest in and to the Marks, together with that part of the good will of the business connected with the use of and symbolized by the Marks, the registrations and applications for registration of the Marks, and the right to sue and collect damages for past infringement of the Marks. Assignor agrees that Assignee may record this Assignment with the United States Patent and Trademark Office or any other applicable governmental office.
