WHEREAS, pursuant to a Security Agreement (the "Original Agreement"), dated as of November 12, 1998 by and between Kansas City Chiefs Football Club, Inc., a Texas corporation (the "Assignor"), and Bank of America, N.A. 

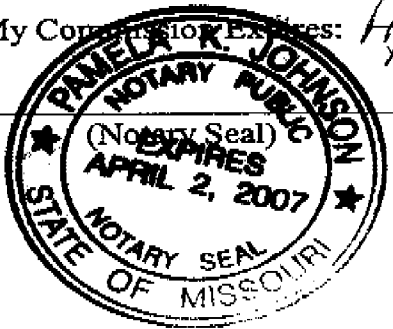
