RELEASE OF SECURITY INTEREST

This Release of Security Interest, effective as of December 3, 2004 (the "Effective Date"), is made by GMAC COMMERCIAL FINANCE LLC, as successor in interest by merger to GMAC COMMERCIAL CREDIT LLC, formally known as BNY FACTORING LLC, as successor by merger to BNY FINANCIAL CORPORATION ("Grantee"), in favor of AZ3, INC., as successor in interest by merger to CAL-JAM, INC. ("Grantor").

WHEREAS, on April 10, 1998, Grantor and Grantee entered into that certain Trademark Assignment of Security (the "Security Agreement") which provided for the grant by Grantor to Grantee of a security interest in the Marks (as that term is defined in the Security Agreement) owned by Grantor; and

WHEREAS, on July 15, 1998, Grantee recorded in the Patent and Trademark Office, U.S. Department of Commerce at Reel/Frame 1754/0651, the Security Agreement, evidence of its security in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, as of the Effective Date, Grantee hereby (1) releases, discharges and relinquishes its security interest in all of the Marks, as listed on Schedule A, and (2) reassigns to Grantor all right, title, and interest that Grantee may have had in the Marks, including all goodwill associated with the Marks. Grantee specifically acknowledges that the Security Agreement is no longer effective as to the Marks, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Marks.

Grantee acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Marks.
