the Registration and in connection with which the Trademark is used, and all claims and demands, if any, including all claims and demands for past infringement, that Assignor may have in connection with the Trademark or the Registration arising before and as of June 1, 1999.

The terms and provisions of this Confirmatory Assignment shall inure to the benefit of Assignee and its successors and assigns, and shall be binding on Assignor and its legal representatives and any corporation controlling Assignor.

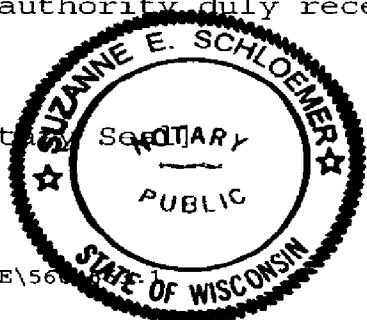
