COPYSECURITY AGREEMENT (TRADEMARKS)

WHEREAS, IMAGING AUTOMATION, INC., a Delaware corporation (successor by merger to Imaging Automation, Inc., a New Hampshire corporation), with a principal place of business at 25 Constitution Drive, Bedford, NH 03110 (the "Company") and ZERO STAGE CAPITAL V LIMITED PARTNERSHIP, with a place of business at 101 Main Street, Suite 1700, Cambridge, Massachusetts 02142 (the "Secured Party") have entered into an Inventory, Accounts Receivable and Intangibles Security Agreement issued as of the date hereof and effective as of February 28, 2002 (the "Security Agreement") in connection with that certain Reimbursement Agreement issued as of the date hereof and effective as of February 28, 2002 made by and between the Company and the Secured Party; and

WHEREAS, the Company is the owner and user of the trademarks listed on Schedule A hereto and identified in said Security Agreement (the "Trademarks"); and

WHEREAS, among the security interests granted by the Company to the Secured Party pursuant to the Security Agreement is a security interest in the Trademarks listed on Schedule A hereto, together with the goodwill of the business associated with and symbolized by such Trademarks; and

WHEREAS, the parties to the Security Agreement contemplate and intend that, in the event a Default (as defined in the Security Agreement) shall have occurred and be continuing, the Secured Party shall have all rights of the Company in and to the Trademarks and the goodwill of the business of the Company associated with and symbolized by the Trademarks as may be necessary or proper in order to enable the Secured Party, as foreclosing secured party, to continue such business of the Company or, following such foreclosure, to transfer to a purchaser all such rights as may be necessary or proper to enable such purchaser to continue such business of the Company;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties reconfirm the terms of the Security Agreement, as if set forth fully herein, and acknowledge that the Secured Party has a security interest in the Trademarks listed on Schedule A hereto, together with the goodwill of the business associated with and symbolized by such Trademarks; as security for the Obligations (as defined in the Security Agreement), the Company hereby collaterally assigns to the Secured Party, and grants a security interest to the Secured Party in and to, all of the Company's right, title and interest in and to said Trademarks and the goodwill of the business associated therewith; the Company agrees that it will not sell or assign any of the Trademarks without the prior written consent of the Secured Party; and the Company and the Secured Party request that the Commissioner of Patents and Trademarks record this document with respect to the Trademarks.

The Company hereby appoints the Secured Party as the Company's attorney-in-fact (with full power of substitution and resubstitution) with the power and authority, after the occurrence and during the continuance of any Default (as defined in the Security Agreement), to execute and deliver, in the name and on behalf of the Company, and to cause the recording of all such further assignments and other instruments as the Secured Party may deem necessary or desirable in order to carry out the intent of the Security Agreement and this Security Agreement






