**TERMINATION OF TRADEMARK AND SECURITY AGREEMENT OF  
FLEET CAPITAL CORPORATION**

This is a Termination of Security Interest, dated as of April 30, 2004, executed by Fleet Capital Corporation, ("Secured Party") as Agent for certain Lenders under that certain Loan and Security Agreement dated August 31, 2001 (the "Loan Agreement") among United Natural Foods, Inc. and certain of its affiliates and subsidiaries (collectively, "Borrowers"), releasing all security interests of the Secured Party in the Trademark Collateral (defined below) owned by Stow Mills, Inc. ("Debtor").

*Recitals*

WHEREAS, Debtor granted Secured Party, as Agent, a security interest in the following Trademarks (a) "Woodstock Orchards", U.S. Trademark Registration Number 1885171; (b) "Stow Mills," U.S. Trademark Registration Number 1477015; (c) "Woodstock Farms," U.S. Trademark Registration 1472520; and (d) "Woodstock," U.S. Trademark Registration Number 1487657 (the "Trademark Collateral"), as evidenced by that certain Trademark and Security Agreement dated as of August 31, 2001.

WHEREAS, Secured Party has agreed to the termination of Secured Party's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates all of the Secured Party's security interests in the Trademark Collateral.
