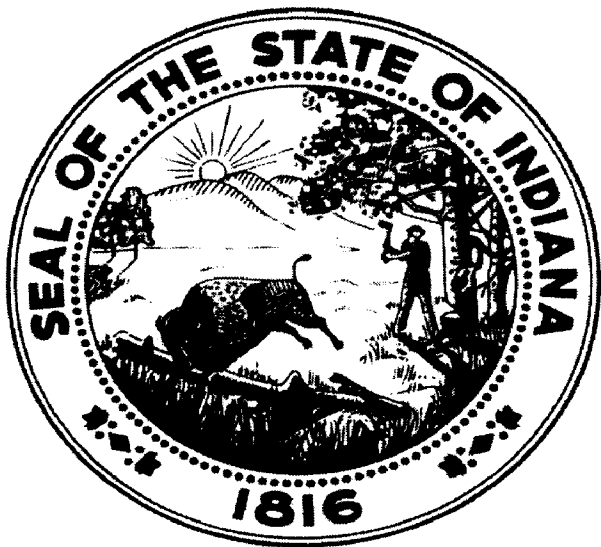

The undersigned officer of JIST Works, Inc. (hereinafter referred to as the "Corporation"), existing pursuant to the provisions of the Indiana Business Corporation Law (the "Act"), desiring to give notice of corporate action effectuating the amendment of a certain individual article of its Articles of Incorporation, as amended, sets forth the following facts:

ARTICLE I

THE AMENDMENT

The exact text of Article I of the Corporation's Articles of Incorporation (hereinafter referred to as the "Amendment"), now is as follows:

"ARTICLE I

Name

The name of the Corporation is **JIST Publishing, Inc.**"

ARTICLE II

MANNER AND ADOPTION OF VOTE

1. Action by Shareholders and Directors. The shareholders and the Board of Directors of the Corporation adopted the terms of the Amendment by combined unanimous written consent of such shareholders and Directors effective January 28, 2000.

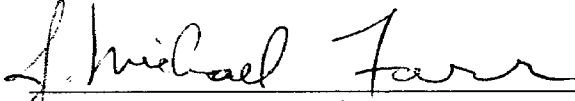
The number of shares entitled to vote in respect of the Amendment was all issued and outstanding shares of Class A Common Stock. The number of shares voted in favor of the adoption of the Amendment was all issued and outstanding shares of Class A Common Stock, and the number of shares voted against such adoption was zero shares of Class A Common Stock.

2. Compliance with Legal Requirements. The manner of the adoption of the Amendment and the vote by which it was adopted constitute full legal compliance with the provisions of the Act, the Articles of Incorporation, and the By-Laws of the Corporation.
