RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("Release") is granted on this 15th day of November, 2004, by Bank of America, N.A., as Administrative Agent (the "Agent"), with principal offices at 600 Peachtree Street, N.E., Atlanta, GA 30308, to BMCM Partnership, LP, a Colorado limited partnership, as Assignor (the "Assignor"), with principal offices at 5661 Crestbrook Drive, Morrison, Colorado 80465, as follows:

W I T N E S S E T H:

WHEREAS, Assignor is the owner of the trademark LET-IT-FLY and U.S. Registration No. 2,428,957 for the trademark LET-IT-FLY (collectively, the "Mark");

WHEREAS, on December 17, 1999, Streetball Sports Venture Partners, L.P., a prior owner of the Mark granted to the Agent a security interest in and to the Mark which security interest was duly recorded on January 5, 2000 at Reel 2009, Frame 0630 in the United States Patent and Trademark Office (the "1999 Security Interest");


WHEREAS, on July 27, 2001, Host Communications, Inc., a prior owner of the Mark granted to the Agent a security interest in and to the Mark which security interest was duly recorded on July 31, 2001 at Reel 2344, Frame 0029 in the United States Patent and Trademark Office (the "2001 Security Interest," together with the 1999 Security Interest, the "Security Interests"); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Mark to the Assignor and to dissolve any and all liens and encumbrances respecting the Mark.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Mark, and more particularly, (i) the Security Interests, (ii) the goodwill of the business symbolized by the Mark, and (iii) all causes of

action arising prior to or after the execution date of the 1999 Security Interest for infringement of any the Mark or unfair competition regarding the Mark, as such rights, title and interest were granted to the Agent pursuant to the Security Interests.




