INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "Release") is made as of June 22, 2004 (the "Effective Date"), by Bank of America, N.A., as Agent for each of the Secured Parties (in such capacity, together with its successors and assigns in such capacity, the "Grantee"), in favor of CDOC, Inc., CIHC, Incorporated, and Conseco Services, LLC (the "Lien Grantors").

WHEREAS, Conseco, Inc. (the "Company"), the banks party thereto, and the Grantee are parties to that certain Credit Agreement, dated September 10, 2003 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to (i) that certain Guarantee and Security Agreement, dated as of September 10, 2003 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement"), by and among the Company, the Subsidiary Guarantors, and the Grantee, and (ii) the other Security Documents, the Lien Grantors have guaranteed certain obligations of the Company and secured such guarantee (the "Lien Grantor's Secured Guarantee of the Secured Obligations") by granting to the Grantee for the benefit of such Secured Parties a continuing security interest in the personal property of the Lien Grantors (capitalized terms used herein and not defined shall have the meanings assigned to such terms in the Security Agreement);

WHEREAS, pursuant to (i) that certain Copyright Security Agreement, executed September 10, 2003 by and among the Grantee and CDOC, Inc.; (ii) that certain Patent Security, executed September 10, 2003 by and among the Grantee and CDOC, Inc.; (iii) that certain Trademark Security Agreement, executed September 10, 2003 by and among the Grantee and CDOC, Inc.; (iv) that certain Trademark Security Agreement, executed September 10, 2003 by and among the Grantee and CIHC, Incorporated; and (v) that certain Trademark Security Agreement, executed September 10, 2003 by and among the Grantee and Conseco Services, LLC (as amended, supplemented, amended and restated or otherwise modified from time to time, collectively, the "IP Security Agreements"), the Lien Grantors granted to the Grantee, to secure the Lien Grantors' Secured Guarantee of the Secured Obligations, a continuing security interest in all of the Lien Grantors' right, title and interest in, to and under the Copyright Collateral, Patent Collateral and Trademark Collateral (as each term is defined in the IP Security Agreements); and

WHEREAS, in accordance with the provisions of the Credit Agreement and the Security Agreement, the Grantee desires to release its security interest in and to the copyrights, patents, and trademarks identified on Schedule A attached hereto (the "Released Intellectual Property").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agree as follows:

1. The Grantee, on behalf of, and as Agent for, the Secured Parties, hereby releases to the Lien Grantors the security interest in, to and under the Released Intellectual Property granted to the Grantee under the IP Security Agreements.

2. This Release may be executed in one or more counterparts, and by the Grantee in separate counterparts, each of which when executed shall be deemed an original but all of which taken together shall constitute one and the same agreement. Copies of executed counterparts transmitted by telecopier or other electronic transmission service shall be effective as delivery of an original executed counterpart of this Release.

3. This Release shall be construed in accordance with and governed by the laws of the State of New York.
