RELEASE dated as of January 18, 2005, by JPMorgan Chase Bank, N.A., as Collateral Agent under the US Security Agreement and Credit Agreement referred to below.

A. Reference is made to the US Security Agreement dated as of September 22, 2000 (as amended, supplemented or otherwise modified from time to time, the "US Security Agreement"), among Select Medical Corporation (the "Company"), each Subsidiary of the Company listed on Schedule I thereto or becoming a party thereto as provided in Section 7.15 thereof (the "Subsidiary Guarantors", the Company and the Subsidiary Grantors being referred to collectively as the "Grantors"), and JPMorgan Chase Bank, N.A. (formerly known as JPMorgan Chase Bank) ("JPMorgan"), as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below), pursuant to which, among other things, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the registered trademark set forth on Annex I hereto (the "Trademark"), which security interest was recorded with the United States Patent & Trademark Office (recorded Sept. 24, 2000 at Reel 002159 and Frame 0938).


B. Reference is made to the Credit Agreement dated as of September 22, 2000 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Company; Canadian Back Institute Limited, a wholly owned subsidiary of the Company; the lenders from time to time party thereto; JPMorgan, as US administrative agent and as collateral agent; JPMorgan Chase Bank, Toronto Branch (as successor to J.P. Morgan Bank Canada (formerly known as The Chase Manhattan Bank of Canada)), as Canadian Agent and Canadian Collateral Agent; Banc of America Securities LLC, as Syndication Agent; and CIBC, Inc., as Documentation Agent.

C. JPMorgan wishes to provide a document suitable for recording in the United States Patent and Trademark office for the purposes of recording the release, relinquishment and discharge of its security interest in the Trademark.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, JPMorgan hereby relinquishes, releases and discharges its security interest in the Trademark.
