WHEREAS, Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of its right, title and interest and goodwill in the Marks;


WHEREAS, Assignee now desires to acquire all of Assignor's entire right, title and interest in and to the Marks; and

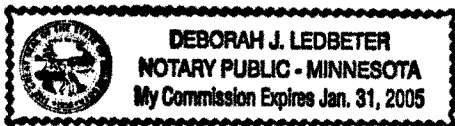
