WHEREAS Stiefel Laboratories, Inc., a corporation of the State of New York, located at 255 Alhambra Circle, Suite 1000, Coral Gables, Florida 33134 has adopted, used, and is using the trademark CLARIPEL for “prescription pharmaceutical preparation, namely a topical cream for lightening of the skin and discolored areas of the skin”, in International Class 005;

AND WHEREAS, Stiefel Laboratories, Inc. filed Application Serial No. 76/111,721 on August 17, 2000 to register its trademark CLARIPEL;

AND WHEREAS, Application Serial No. 76/111,721 issued into Registration No. 2,884,585 on September 14, 2004;
