**RELEASE OF SECURITY INTEREST
IN TRADEMARKS AND PATENTS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (the "Agreement") is made as of the 29th day of January, 2004, among Microwave Instrumentation Technologies, LLC, a Delaware limited liability company ("MI Technologies"), Silicon Valley Bank ("Silicon"), and Wachovia Bank, N.A. ("Wachovia").
