**TERMINATION AND RELEASE  
(Trademarks)**

This TERMINATION AND RELEASE is dated as of February 16, 2005 and made by Wells Fargo Foothill, Inc. (the "Secured Party"), in favour of Corel Corporation, an Ontario corporation and Corel Inc., a Delaware corporation (the "Pledgors").

WITNESSETH:

WHEREAS, this Termination and Release shall be effective as of February 16, 2005;

WHEREAS, the Pledgors granted two (2) security interests in certain Collateral (as hereinafter defined) to the Secured Party (collectively, the "Security Interest"); and

WHEREAS, the first Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on October 6, 2003 at Reel 2838, Frame 0657;

WHEREAS, the second Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on June 28, 2004 at Reel 3012, Frame 0094; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral as follows:

1. Collateral. The term "Collateral", as used herein, shall mean all of the Pledgors' right, title and interest of every kind and nature in the trademarks and service marks set forth on Schedule A attached hereto and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all reissues, continuations, continuations-in-part or extensions thereof/all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or receivable with respect thereto, including, without limitation, all damages and payments receivable for past, present and/or future infringements thereof; (iv) the right to sue for past, present and/or future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of the Pledgors' business connected with or symbolized by the foregoing.

2. Further Assurances. The Secured Party hereby agrees to execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
