RELEASE OF SECURITY INTEREST

This RELEASE, dated as of February 8, 2005, is made by Lehman Commercial Paper Inc. (“LCPI”), as administrative agent, pursuant to the termination of the Guarantee and Collateral Agreement dated as of March 15, 1999 between LCPI and B&G Foods Holdings Corp.; B&G Foods, Inc.; BGH Holdings, Inc.; Bloch & Guggenheimer Inc.; Roseland Distribution Company; Burns & Ricker, Inc.; RWBV Acquisition Corp.; Trappey’s Fine Foods, Inc.; Maple Grove Farms of Vermont, Inc.; Heritage Acquisition Corp.; and William Underwood Company (collectively, the “Borrowers”) (the “Guarantee and Collateral Agreement”).

W I T N E S S E T H:

WHEREAS, the Borrowers and LCPI entered into a Revolving Credit Agreement and a Term Loan Agreement, each dated as of March 15, 1999 (the “Credit Agreements”), pursuant to which LCPI extended credit to the Borrowers, and in return the Borrowers granted security interests pursuant to the Guarantee and Collateral Agreement by Borrowers in favor of LCPI, recorded with the U.S. Patent and Trademark Office in connection with the Borrowers’ trademarks on April 21, 1999, Reel/Frame 1888/0213, and in connection with Borrower’s patent on April 21, 1999, Reel/Frame 009922/0145, and recorded with the Copyright Office in connection with Borrowers’ copyright registrations on April 21, 1999, at V3433 D533-535 P1-72.

WHEREAS, LCPI acknowledges full payment, performance and satisfaction of the Note issued pursuant to the Credit Agreements secured by the above-referenced Guarantee and Collateral Agreement; and


WHEREAS, the Borrowers have requested that LCPI release its security interest in the Collateral, as defined in the Guarantee and Collateral Agreement in connection with the termination of the Credit Agreements and the Guarantee and Collateral Agreement (the “Released Collateral”).

NOW, THEREFORE, LCPI hereby **RELEASES** all of its security interest in the Released Collateral, namely, the trademarks listed in Schedule A, the trademark registrations listed in Schedule B, the patent registration listed in Schedule C, and the copyright registrations listed in Schedule D, all schedules attached hereto and incorporated herein by reference, and any other Collateral described in the aforementioned Guarantee and Collateral Agreement, including any licenses.

LCPI agrees, at the Borrowers' expenses, to cooperate with the Borrowers and to provide the Borrowers with the information and additional authorization necessary to effect the release of LCPI's security interest in the Released Collateral.




