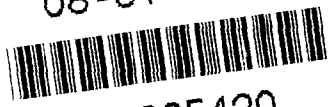

Release of Memorandum of Amendment to Trademark Security Interest Assignment


