

**TERMINATION OF SECURITY INTEREST**

This Termination of Security Interest, dated as of August 25, 2004, is executed by Fleet National Bank, a national banking association, with an office at 100 Federal Street, Boston, Massachusetts 02110, as administrative agent for itself and certain secured parties (the "Administrative Agent"), to release all security interests of the Administrative Agent in the Intellectual Property (defined below) owned by Advance Watch Company Ltd. ("Advance Watch").

**Recitals**

WHEREAS, Advance Watch previously granted to Administrative Agent a security interest in, among other things, the patents, trademarks and other intellectual property items listed on Schedule A (the "Intellectual Property") as evidenced by that certain Amended and Restated Intellectual Property Security Agreement dated July 28, 2000 in the United States Patent and Trademark Office on April 26, 1999 and recorded with the United States Patent and Trademark Office at Reel 001890, Frame 0320 (the "Security Agreement").

WHEREAS, the Administrative Agent desires to terminate the Secured Party's security interest in the Intellectual Property owned by Advance Watch.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates all of the Administrative Agent's security interests in the Intellectual Property owned by Advance Watch, including, without limitation, that set forth at Reel 001890, Frame 0320.
