TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 31, 2004, is made by General Electric Capital Corporation, as agent ("Agent") for the lenders ("Lenders") from time to time signatory to that certain Second Amended and Restated Credit Agreement, dated as of May 10, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Insight Pharmaceuticals Corporation ("Borrower"), Pharmaceuticals Holdings, Inc., Agent and Lenders.

WHEREAS, in connection with the Credit Agreement, Borrower has granted a security interest (the "Pledge") in certain personal property to Agent for its benefit and the benefit of Lenders, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");

WHEREAS, evidence of the Pledge with respect to the Trademarks was recorded at the United States Patent and Trademark Office on April 16, 2002 at Reel 2493 and Frame 0695; and

WHEREAS, evidence of the Pledge with respect to the Trademarks was recorded at the United States Patent and Trademark Office on January 13, 2003 at Reel 2650 and Frame 0241; and

WHEREAS, evidence of the Pledge with respect to the Trademarks was recorded at the United States Patent and Trademark Office on March 26, 2003 at Reel 2699 and Frame 0970; and

WHEREAS, evidence of the Pledge with respect to the Trademarks was recorded at the United States Patent and Trademark Office on May 13, 2003 at Reel 2649 and Frame 0852; and

WHEREAS, Agent has agreed to terminate and release its security interest in all of the Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, Agent hereby terminates and releases the security interest granted to the Agent for its benefit and the benefit of Lenders in the following Trademarks:

1. all of the Borrower's Trademarks to which the Borrower is a party including those referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Borrower against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
