ASSIGNMENT OF TRADEMARKS

WHEREAS, Peregrine Systems, Inc., a Delaware corporation (“Peregrine”) and Inovis, Inc., a Georgia Corporation f/k/a/ Peregrine Connectivity, Inc., a Georgia corporation (“Inovis”) entered into an Intellectual Property Agreement dated June 12, 2002 (“IP Agreement”), in which, pursuant to Section 2.1 of the IP Agreement, Peregrine agreed to assign, transfer and otherwise acknowledged the ownership interest of Inovis in and to all of the products and underlying intellectual property, including trademarks, identified in Exhibit A of the IP Agreement;

WHEREAS, Peregrine agreed to execute a trademark assignment, substantially similar to Exhibit C-2 of the IP Agreement, upon request by Inovis to confirm the assignment, transfer, and ownership interest of Inovis in and to all of the products and underlying intellectual property, including trademarks, identified in Exhibit A of the IP Agreement, effective as of June 12, 2002;

WHEREAS, Peregrine had adopted, used, and was using the following marks (collectively “Marks”), which are registered in the United States Patent and Trademark Office:

WHEREAS, Inovis has adopted, has used, and is now using the Marks pursuant to the IP Agreement, and is desirous of acquiring the Marks, together with the goodwill of the business symbolized by the Marks, and the registrations thereof.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Peregrine does hereby quitclaim, assign, transfer and convey unto Inovis all

right, title, and interest in and to the Marks, together with the goodwill of the business, products, and services symbolized by the Marks, the above identified registrations thereof, any and all common law rights and domain name registrations, and all right to sue for past, present, and future infringement thereof.

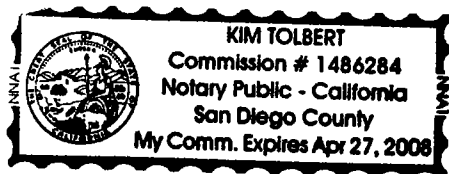
