RELEASE OF SECURITY INTEREST

RECITALS

Secured Party hereby terminates all liens, security interests, assignments, and other interests of Secured Party in all of Grantors' Trademarks, including, without limitation, its trademarks, service marks, trademark and service mark applications and trade names listed in Exhibit A, which is attached hereto and incorporated herein by reference.
