DISCHARGE OF RECORDED SECURITY INTEREST
(Dolan Media Company)

WHEREAS, by a Collateral Assignment (Trademarks) dated July 31, 2003 (the "Security Agreement") DMC II Company (hereinafter referred to as "DMC II") granted a security interest in the United States trademarks listed in Exhibit A attached hereto (the "Collateral") to U.S. Bank National Association, as Agent (hereinafter referred to as the "Secured Party"), in order to secure repayment of certain amounts then owing to the Secured Party (herein called the "Indebtedness").

AND WHEREAS the Security Agreement was recorded in the records of the United States Patent and Trademark Office (herein referred to as the "U.S. Trademark Office") on November 13, 2003 and such recordation is located on Reel 002746 at Frame 0376 of the U.S. Trademark Office.


AND WHEREAS a Change of Name to assign DMC II's security interests to Dolin Media Company (hereinafter referred to as "Dolin Media") was subsequently recorded in the U.S. Trademark Office on January 27, 2004 and such recordation is located on Reel 002782 at Frame 0866 of the U.S. Trademark Office.

AND WHEREAS a Corrective Assignment to correct Dolin Media's name to Dolan Media Company (hereinafter referred to as "Dolan Media") was subsequently recorded in the U.S. Trademark Office on February 4, 2004 and such recordation is located on Reel 002787 at Frame 0883 of the U.S. Trademark Office.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Secured Party of the full amount of the Indebtedness, the Secured Party hereby (a) releases and discharges all the security interests granted by the Security Agreement, being the security interests granted in respect of the patents and trademarks and all other Collateral and (b) acknowledges, confirms and agrees that the Security Agreement is discharged, released and terminated and of no further force or effect.
