TERMINATION OF SECURITY INTEREST

This **TERMINATION OF SECURITY INTEREST**, dated as of February 16, 2005, is made by Citicorp USA, Inc. (the "Administrative Agent").

WHEREAS, pursuant to that certain Security Agreement, dated November 15, 2002 (the "Security Agreement"), Broadwing Communications Services Inc. (f/k/a IXC Communications Services, Inc.), Broadwing Communications Inc., Zoomtown.com Inc., Broadwing Holdings Inc., Broadwing Technology Solutions Inc., Cincinnati Bell Any Distance Inc., Cincinnati Bell Wireless Holdings LLC, Cincinnati Bell Wireless Company, Cincinnati Bell Telecommunications Services Inc., Cincinnati Bell Public Communications Inc., Broadwing Financial LLC, Broadwing Communications Real Estate Services LLC, Broadwing Telecommunications Inc., IXC Business Services, LLC, Broadwing Communications Services of Virginia, Inc., IXC Internet Services, Inc., and Broadwing Local Services Inc. (collectively, the "Grantors") granted a security interest in favor of the Administrative Agent with respect to the Collateral (as defined in the Security Agreement);

WHEREAS, the Grantors executed an Intellectual Property Security Agreement (the "IP Security Agreement"), dated November 15, 2002, pursuant to which the Grantor confirmed the grant of the security interest to the Administrative Agent under the Security Agreement with respect to the trademarks set forth on Schedule A attached hereto (the "Trademarks");

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office on February 5, 2003 at Reel 2669 and Frame 0938; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Trademarks.


NOW, THEREFORE, for valuable consideration, the Administrative Agent hereby terminates and releases on to the Grantors, without warranty of any kind except as expressly provided under the Security Agreement, the security interests granted to the Administrative Agent in the following:

1. the Trademarks;
2. all goodwill of the business connected with the use of, and symbolized by, the foregoing; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantors against third parties for past, present or future (i) infringement or dilution of the foregoing, or (ii) injury to the goodwill associated with the foregoing.

IN WITNESS WHEREOF, the Administrative Agent has caused this Termination of Security Interest to be duly executed as of the date first set forth above.
