This TRADEMARK RELEASE is made as of January 6, 2005, by KEYBANK NATIONAL ASSOCIATION, as Agent ("*Agent*").

2. Agent hereby reassigns, grants and conveys to CooperVision, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks granted to Agent pursuant to the Security Agreements.

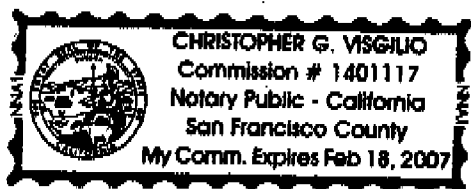
