

TRADEMARK RELEASE

This TRADEMARK RELEASE is made as of January 6, 2005, by KEYBANK NATIONAL ASSOCIATION, as Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and CooperSurgical, Inc., a Delaware corporation ("*CooperSurgical*"), were parties to that certain Security Agreement dated as of May 1, 2002 (the "*Security Agreement*") and that certain Intellectual Property Collateral Assignment Agreement dated as of May 1, 2002 (the "*Assignment Agreement*," collectively with the Security Agreement, the "*Security Agreements*"), pursuant to which CooperSurgical granted a security interest to Agent in certain U.S. trademark registrations and applications set forth on Exhibit A hereto (the "*Trademarks*"); and

WHEREAS, the Assignment Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on July 11, 2002, at Reel 2535, Frame 0688.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of CooperSurgical's right, title and interest in and to the Trademarks granted to Agent pursuant to the Security Agreements.
2. Agent hereby reassigns, grants and conveys to CooperSurgical, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks granted to Agent pursuant to the Security Agreements.
