RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of September 27, 2004, made by Transamerica Business Capital Corporation, formerly known as Transamerica Business Credit Corporation ("Lender").

WHEREAS, American Circuit Breaker Corporation ("ACBC"), Parallax Power Components, LLC ("Parallax", and together with ABC, the "Borrower") and Transamerica Business Capital Corporation are parties to a certain Loan and Security Agreement dated as of December 29, 1994, (as amended, restated, supplemented and otherwise modified from time to time, the "Agreement").

WHEREAS, as partial security for the borrower's obligations, the Borrower has executed a certain Intellectual Property Security Agreement (the "Security Agreement"), dated as of June 29, 2001, pursuant to which the Borrower granted a security interest in and to, inter alia, the trademarks referenced therein. Notice of the Security Agreement was recorded with the United States Patent & Trademark Office at reel 2331 and frame 0622 on July 19, 2001.

WHEREAS, the Borrower has requested that Lender release its security interest in the trademarks referenced in the Security Agreement and reassign the same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases its security interest in the trademarks referenced in the Security Agreement, including, without limitation, each trademark, trademark registration and trademark application listed on Exhibit A annexed hereto.

2. Lender hereby reassigns, grants and conveys to the Borrower, without any representation, recourse or undertaking by Lender, all of Lender's rights, title and interest, in and to the trademarks, as such rights, title and interest are granted in the Security Agreement.
