**NOTICE OF RELINQUISHMENT OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

THIS NOTICE OF RELINQUISHMENT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (“Notice of Relinquishment”), dated as of April 8, 2005, is made in favor of Metro-Goldwyn-Mayer Studios, Inc. (together with its successors, “MGM”), Orion Pictures Corporation (together with its successors, “Orion”), the other Persons listed on the signature pages of the Security Agreement and the Additional Grantors (MGM, Orion, the other Persons so listed and the Additional Grantors being, collectively, “the Grantors”) by Bank of America, N.A., as administrative agent (“the Administrative Agent”) for the benefit of the Secured Parties (as defined in the Credit Agreement) under that certain Second Amended and Restated Credit Agreement, dated as of July 21, 2000 (as amended, supplemented, replaced, or otherwise modified from time to time, the “Credit Agreement”, and as originally in effect from time to time prior to the date of the Credit Agreement, the “Original Credit Agreement”). Capitalized terms used and not defined herein shall have the meanings given such terms in the Credit Agreement.

**W I T N E S S E T H:**

**WHEREAS**, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrowers;

**WHEREAS**, in connection with the Credit Agreement, the Grantors have executed and delivered a Second Supplement to the Amended and Restated Security Agreement dated as of July 21, 2000 in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement") in order to grant to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in the Collateral to secure their respective Secured Obligations;

**WHEREAS**, in connection with the Security Agreement, the Grantors have executed and delivered:

1. a Third Supplement to Amended and Restated Security Agreement dated June 11, 2002 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on June 14, 2002 at Reel/Frame 2533.0628, 2534/0378, 2434/0504, 2534/0434, 2533/0878, 2533/0801, 2533/0745, 2534/0063, 2534/0133;
2. a First Supplement to Amended and Restated Trademark Security Agreement dated June 11, 2002 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on June 14, 2002 at Reel/Frame(s) 2533/0628, 2534/0378, 2434/0504, 2534/0434, 2533/0878, 2533/0801, 2533/0745, 2534/0063, and 2534/0133;

3. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated June 30, 2002 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on September 20, 2002 at Reel/Frame 2587/0930 et seq.;
4. a Quarterly Supplement to Amended and Restated Trademark Security Agreement December 31, 2002 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on March 12, 2003 at Reel/Frame 2691/0675;
5. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated March 31, 2003 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office May 7, 2003 at Reel/Frame 2852/0572;
6. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated June 30, 2003 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on June 22, 2004 at Reel/Frame 2997/0924;
7. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated September 30, 2003 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with

the United States Patent and Trademark Office on November 5, 2003 at Reel/Frame 2858/0810;

8. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated December 31, 2003 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on February 6, 2004 at Reel/Frame 2911/0106;
9. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated March 31, 2004 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was recorded with the United States Patent and Trademark Office on May 10, 2004 at Reel/Frame 2966/0015;
10. a Quarterly Supplement to Amended and Restated Trademark Security Agreement dated June 30, 2004 in favor of the Administrative Agent, for the benefit of the Secured Parties, which was filed for recordation in the Trademark Office on September 24, 2004;

**WHEREAS**, the Administrative Agent has duly authorized the execution, delivery and performance of this Notice of Relinquishment, the purpose of which is to give notice of the relinquishment of security interest granted in favor of the Administrative Agent, for the benefit of the Secured Parties, with respect to certain of the Trademark Collateral as identified in Schedule A attached hereto (the "Released Trademark Collateral").

**NOW THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent, on its own behalf and on behalf of the Secured Parties, hereby releases its security interest in the Released Trademark Collateral.

This Agreement may be executed in one or more counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

Other than as set forth herein, all of the Administrative Agent's rights under the Credit Agreement, the Security Agreement or the Copyright Security Agreement shall remain in full force and effect as if this Notice of Relinquishment had never been executed.
