
**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, PROVINCE HEALTHCARE COMPANY (the “Pledgor”) is the owner of the trademarks and service marks listed on Schedule A attached hereto, which marks are registered or have pending registrations in the United States Patent and Trademark Office as set forth on Schedule A attached hereto (all such trademarks, service marks, registrations and applications, collectively, the “Trademarks”); and

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Pledge and Security Agreement (as amended, modified, restated or supplemented from time to time, the “Security Agreement”), dated as of November 13, 2001, in favor of First Union National Bank, n/k/a Wachovia Bank, National Association, as Administrative Agent (the “Administrative Agent”), with offices at One Wachovia Center, 301 South College Street, Charlotte, North Carolina 28288-0755, and pursuant thereto executed and delivered a Grant of Security Interest in Trademarks (the “Trademark Assignment”) as recorded in the United States Patent and Trademark Office in Reel 002397, Frame 0144, pursuant to which the Pledgor granted to the Administrative Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Administrative Agent’s right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Trademark Assignment in the United States Patent and Trademark Office as aforesaid may be removed of record.
