TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October ²⁹, 2004, by JPMorgan Chase Bank, a New York Banking corporation, as Administrative and Collateral Agent (“Agent”).

WITNESSETH:

WHEREAS, Agent and Esoterix, Inc., a Delaware corporation (“Esoterix,”), were parties to a security agreement dated on or about September 30, 2002 (the “Security Agreement”), pursuant to which Esoterix granted a security interest to Agent in, and a collateral assignment to Agent of, among other things, the trademarks set forth on Exhibit A hereto; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on October 17, 2002, at Reel 2616/ Frame 0356; and

WHEREAS, Esoterix has requested that Agent release its security interest in the Trademarks and reassign the same to Esoterix;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Esoterix’s right, title and interest in and to all of the following:

(a) each trademark, trademark registration and trademark application, including, without limitation, the trademarks, trademark registrations (together with any reissues, continuations or extensions thereof) and trademark applications referred to in Exhibit A annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application;

(b) each trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each trademark license; and

(c) all products and proceeds of the foregoing, including, without limitation, any claim by Esoterix against third parties for past, present or future (a) infringement or dilution of any trademark or trademark registration including, without limitation, the trademarks and trademark registrations referred to in Exhibit A annexed hereto, the trademark registrations issued with respect to the trademark applications referred in Exhibit A and the trademarks licensed under

any trademark license or (b) injury to the goodwill associated with any trademark, trademark registration or trademark licensed under any trademark license.

2. Agent hereby reassigns, grants and conveys to Esoterix, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the trademarks, and the goodwill of Esoterix's business connected with the use of and symbolized by the trademarks.


