**TRADEMARK RELEASE**

This Release granted on this \_\_\_ day of April, 2005, by DEUTSCHE BANK AG, NEW YORK BRANCH, as Collateral Agent ("Agent"), to Syva Company, a Delaware corporation ("Grantor"), as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor pursuant to the terms and conditions of that certain Security Agreement among Deutsche Bank AG, New York Branch, Dade Behring Inc., Dade Behring Holdings, Inc. and certain other subsidiaries of Dade Behring Holdings, Inc. dated October 3, 2002 (the "Security Agreement"), has heretofore granted to the Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in the Security Agreement) between the Agent and the Grantor; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Marks, and more particularly, the security interest in the trademarks, mark registrations and mark applications as set forth on Schedule A hereto, granted to Agent by the Grantor by the Security Documents (as defined in that certain Credit Agreement among Deutsche Bank AG, New York Branch, Dade Behring Holdings, Inc., Dade Behring Inc., various lending institutions, Deutsche Bank Securities Inc., General Electric Capital Corporation and the Royal Bank of Scotland PLC dated October 3, 2002), which Assignment was duly recorded on December 18, 2002 at Trademark Reel 002637, Frame 0788 in the United States Patent and Trademark Office.


