TERMINATION AND RELEASE OF FILING AGAINST, AND SECURITY INTEREST IN, CERTAIN TRADEMARKS dated as of April 27, 2005, by WELLS FARGO BUSINESS CREDIT, INC., a Minnesota corporation (the "Secured Party").

WHEREAS, Pacific Market International, LLC, a Washington limited liability company (the "Grantor"), and the Secured Party entered into a Patent and Trademark Security Agreement, dated as of October 21, 2003 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2003, at Reel 002741, Frame 0176 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Released Intellectual Property listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Released Intellectual Property, effective as of the date set forth above.
