## ASSIGNMENT

Whereas, the undersigned is informed and believes that Cable & Wireless Internet Services, Inc., a Delaware corporation ("CWIS"), adopted the trademarks identified on Schedule A; and

Whereas, pursuant to that certain Amended and Restated Asset Purchase Agreement, dated as of January 23, 2004 (the "Asset Purchase Agreement"), by and among CWIS and certain of its affiliates, as Sellers thereunder, and SAVVIS, Inc., a Delaware corporation located at One Savvis Parkway, Town & Country, Missouri 63017 and formerly known as SAVVIS Asset Holdings, Inc. ("Assignee"), Assignee acquired said trademarks and the Application and Registration thereof, along with the ongoing business and the goodwill of the business pertaining thereto (collectively, the "Trademarks") as of February 13, 2004 to the extent and on the terms set forth in the Asset Purchase Agreement; and


Whereas, AlixPartners, LLC, a Delaware limited liability company in its capacity as Trustee of the Omega Liquidating Trust (the "Trustee"), is the successor-in-interest to CWIS pursuant to that certain Omega Liquidating Trust Agreement dated as of August 4, 2004 (which was entered into in accordance with the provisions of that certain Third Amended Joint Plan of Liquidation of Assignors and certain of their affiliates (which was confirmed by an order of the United States Bankruptcy Court for the District of Delaware on July 14, 2004)), pursuant to which, among other things, a liquidating trust for all of the assets of CWIS and certain of its affiliates was established, and substantially all of the assets of CWIS and certain of its affiliates were transferred to such liquidating trust; and

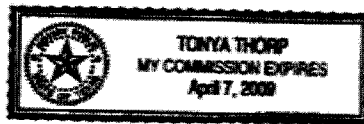
Whereas, CWIS filed a Certificate of Dissolution with the Secretary of State of the State of Delaware on August 4, 2004 and ceased its corporate existence as of such date.
