**RELEASE OF TRADEMARK SECURITY AGREEMENT
AND SECURITY INTERESTS**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT AND SECURITY INTERESTS (this "Release") is entered into as of August 30 2000, by BT COMMERCIAL CORPORATION, as Agent (the "Agent") under that certain Credit Agreement, as amended (the "Credit Agreement"), dated as of March 5, 1996, among Monaco Coach Corporation (the "Borrower"), certain financial institutions party thereto, and the Agent, and has reference to the following facts:

WHEREAS, to secure its obligations under the Credit Agreement and the other Credit Documents (as defined therein), Agent was granted a security interest by Borrower in certain licenses, trademarks, trademark applications, trade names, assumed names, service marks and service mark applications, and all books and records evidencing or containing information regarding or otherwise pertaining to any of the foregoing (collectively, the "Trademark Collateral") under that certain Confirmation and Grant of Security Interests in Trademarks and Trademark Applications (the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on March 15, 1996 at Reel 1440, Frame 0899, against the trademarks listed on the schedule attached thereto; and

WHEREAS, Agent has received consideration for a full and complete release of the security interest and liens on all of the Trademark Collateral, and now wishes to release such security interest and liens in the Trademark Collateral (including, without limitation, the trademarks listed on Schedule 1 attached hereto);

NOW THEREFORE, Agent represents and agrees as follows:

1. Agent hereby releases, cancels and terminates all of its right, title and interest in and to the Trademark Collateral, including its security interest in and liens on the Trademark Collateral and all other rights with respect to the Trademark Collateral, and reconveys and assigns any and all right, title and interest that it may have in and to the Trademark Collateral without any representation or warranty.
2. Without limiting the generality of the foregoing, this Release is intended to and shall forever terminate and reconvey the irrevocable rights in the Trademark Collateral conveyed to Agent under the Trademark Security Agreement.
3. Agent agrees that hereafter it will not take any action with respect to the Trademark Collateral.

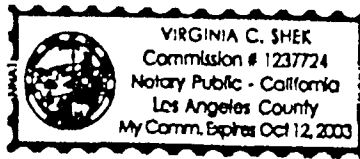
